Review, discuss & take action regarding contract between SJC ESD 2 and Waterwood Improvement Association, Inc.

A motion was made by Commissioner Chrestopoulos, seconded by Commissioner Schwebach to table until we get it back from attorney. Commissioner Hayman abstained. Motion Carried.
